# A RESOLUTION AUTHORIZING THE CHEROKEE NATION WAREHOUSE TO DONATE SURPLUS ITEMS TO TAHLEQUAH POLICE DEPARTMENT

WHEREAS, the Cherokee Nation, since time immemorial, has exercised the sovereign rights of self-government on behalf of the Cherokee people.

WHEREAS the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that have been deemed surplus:

- (1) Leg Press machine
- (1) Chest compression machine
- (2) Peak Pilates fitness chairs
- (2) Workout benches
- (5) Step up boxes w/adapters
- (1) Ping Pong table
- (7) Balance balls
- (1) Precore Stretch Trainer
- (2) Adjustable workout benches
- (1) Exercise bike

The Cherokee Nation Warehouse desires to donate these items in "as-is" condition.

WHEREAS the Tahlequah Police Department, located within the Cherokee Nation's jurisdictional boundaries, operates on limited funds, and donating said items would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION** that the Tribal Council authorizes Cherokee Nation Warehouse to donate these surplus items to Tahlequah Police Department as set out above.
