# A RESOLUTION AUTHORIZING THE CHEROKEE NATION WAREHOUSE TO DONATE SURPLUS ITEMS TO HULBERT PUBLIC SCHOOL

WHEREAS, the Cherokee Nation, since time immemorial, has exercised the sovereign rights of self-government on behalf of the Cherokee people.

WHEREAS the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that have been deemed surplus:

- (3) Box Jumps
- (1) Rogue Abram machine
- (2) Olympic Bars

The Cherokee Nation Warehouse desires to donate these items in "as-is" condition.

**WHEREAS** the Hulbert Public School, located within the Cherokee Nation's jurisdictional boundaries, operates on limited funds, and donating said items would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION** that the Tribal Council authorizes Cherokee Nation Warehouse to donate these surplus items to Hulbert Public School as set out above.
