

An Act

LEGISLATIVE ACT 14-11

AN ACT AMENDING LEGISLATIVE ACT #29-10 AUTHORIZING THE COMPREHENSIVE BUDGET FOR FISCAL YEAR 2011 – Mod. 8; AND DECLARING AN EMERGENCY

BE IT ENACTED BY THE CHEROKEE NATION:

SECTION 1. TITLE AND CODIFICATION

This legislative act shall be titled and codified as “An Act Amending Legislative Act #29-10 Authorizing the Comprehensive Budget for Fiscal Year 2011 – Mod. 8”.

SECTION 2. PURPOSE

The purpose of this amendment is to authorize and approve the use of funds, subject to the availability of such funds, in accordance with Section 4, changing the amounts of certain cost centers approved in the “Comprehensive Budget Act for Fiscal Year 2011” or subsequent amendment. The cumulative total of the budget is increased by \$24,841,987 for a total budget authority of \$654,050,423. The following items are identified as selective General Fund sources in excess of appropriated uses to wit:

SECTION 3. LEGISLATIVE HISTORY

The provisions of compliance, policy of accountability, authorities and severability provided in Legislative Act #21-09 are applicable to this amendment.

SECTION 4. FUNDING AUTHORIZATIONS

The changes reflect increases to cost centers set forth in the program budget justifications incorporated herein. This modification request changes the total amount of the comprehensive budget authorization by an increase of \$24,761,014 to wit:

- A. A reallocation in the **General Fund** budget authority resulting in a **\$0** net impact related to the Tribal Burial Program as well as a grant cash match requirement.

- B. A decrease in the **Indirect Cost Pool** budget authority of <\$64,333> related to the Career Services Group.
- C. An increase in the **Enterprise Fund** budget authority of \$1,009,072 related to the consolidation of loan funds for the creation of a new Commercial Loan Fund.
- D. An increase in the **IHS Self Governance – Health Fund** budget authority of \$23,263,389 related to prior year carryover funding.
- E. An increase in the **HUD Fund** budget authority of \$101,555 related to an ICDBG award for a new Cherokee Creativity Center.
- F. An increase in the **NAHASDA Fund** budget authority of \$4,331 related to the Day Work Training program.
- G. An increase in the **Capital Projects Funds** budget authority of \$447,000 related to the Hastings Warehouse and Physical Therapy Building Expansion projects.

SECTION 5. PROVISIONS AS CUMULATIVE

The provisions of this Act shall be cumulative to existing law.

SECTION 6. SEVERABILITY

The provisions of this Act are severable and if any part or provision hereof shall be held void the decision of the court so holding shall not affect or impair any of the remaining parts or provisions of this Act.

SECTION 7. EFFECTIVE DATE: EMERGENCY DECLARED

It being immediately necessary for the welfare of the Cherokee Nation, the Council hereby declares that an emergency exists, by reason whereof this Act shall take effect immediately upon its approval and signatures.

SECTION 8. SELF-HELP CONTRIBUTIONS

To the extent that this Act involves programs or services to citizens of the Nation or others, self-help contributions shall be required, unless specifically prohibited by the funding agency, or a waiver is granted due to physical or mental incapacity of the participant to contribute.



Re: Review of Budget Modification – 8

Per your request, I have reviewed the administration's budget modification request for this month's Executive & Finance Committee Meeting. Below is a summary of my review:

A. MAY GRANTS RECEIVED (REPORTING ONLY):

B. MOD – 8 (25 budgets) Net Increase in budget authority - \$24,761,014:

General Fund (Tribal): (\$43,389 Reallocations - \$0 Net Impact)

- (1): Contingencies Reserve: Requesting an <\$18,000> reduction in the reserves to fund an increase in the Tribal Burial Program (see item #3 below).
- (2): Cash Match For Grants: Requesting a reallocation of \$25,389 to fund a transfer for the cash matching requirements of the newly received HUD funded Creativity Center (see item #22 below).
- (3): Tribal Burial Program: Requesting a funding increase of \$18,000 provided by the Contingency Reserve.

Indirect Cost Pool: (Decrease - <\$64,333>)

- (4): Career Services: Budgeting a decrease of <\$64,333> related to performance incentive fees.

Enterprise Fund: (Transfers - \$997,629 & Expenditure Increase - \$11,443)

(5 thru 7): Commercial (Micro-Enterprise) Loan Fund: Requesting to create a new Commercial Loan Fund by the combining the previously titled Micro-Enterprise Loan Fund with the Economic Development E-Fund and the CDFI Loan Fund. The net effect after the combination reflects the majority of this budget increase is merely authorizing \$997,629 of fund balance transfers to accomplish the consolidation. A nominal increase in bad debt expense is also reflective in this request of \$11,443.

IHS – Self Governance Health Fund: (Increase - \$23,263,389)

This Fund's significant increase to its current year budget is due to bringing forward \$24,077,110 of prior year carryover not previously budgeted. This increase will bring the total prior year carryover to \$43,794,820. This increase is largely being requested on capital related budgets, as itemized below:

HUD Fund: (Increase - \$101,555)

(22): Cherokee Creativity Center: Requesting an increase in spending authority of \$101,555 related to the recently awarded ICDBG funds.

NAHASDA Fund: (Increase - \$4,331)

(23): Career Svc- Day Work Program: Requesting a slight increase in spending authority related to prior year carryover funds.

Capital Projects Fund: (Increase - \$447,000)

(24): Hasting Warehouse: Requesting an increase of \$32,350 for a total budget of \$4,231,350. This slight increase is transferred from item #18 above. No documentation related to this increase was provided.

(25): WWH Physical Therapy Bldg Expansion: Requesting an increase of \$414,650 for a total budget of \$2,842,950. This increase is also transferred from item #18 above. No documentation was provided related to this increase.

C. CEMETERIES, LAW ENFORCEMENT & COMMUNITY ASSISTANCE FUNDS:

The attached lists of projects have been approved, or are being requested to be approved in this Executive/Finance Committee. These projects have already been appropriated; therefore, there is no need to appropriate the funds again. This list is for informational purposes and is included within this mod package review for inclusion purposes.

Summary:

After reviewing the submission of Mod-8 by administration, I find no technical issues surrounding these requests, nor do I have any concerns related to their respective carryover estimates. If I can provide any further information, please do not hesitate to contact me.
