### CALL TO ORDER

Chair Frailey called the meeting to order at 1:00 p.m.

### INVOCATION

Councilor Snell gave the invocation.

### ROLL CALL

### APPROVAL OF MINUTES

Councilor Anglen moved to approve the December 13th regular session minutes. Councilor Thornton seconded the motion. Councilor Cowan Watts moved to amend the minutes to include more depth on some of the more critical issues. Councilor Thornton seconded the motion. Mr. Hembree stated they would need to present in the same manner as an amendment to legislation.

Councilor Cowan Watts moved to table to next month. Councilor Coates seconded the motion. The motion carried.

### APPROVAL OF MINUTES

Councilor Hoskin Jr. moved to approve the December 12th subcommittee minutes. Councilor Glory-Jordan seconded the motion. The motion carried.

## AMEND THE AGENDA

Councilor Hoskin Jr. moved to amend the agenda to add the legislation that passed out of the impeachment subcommittee. Copies of the legislation have been provided. Councilor Glory-Jordan seconded the motion. The motion carried.

**REPORTS**:

Marshal Service - Shannon Buhl

*Mr.* Buhl offered to answer questions from the report provided; he offered to make changes as to how the report is provided. Councilor Cowan Watts inquired about the update she requested on the Claremore Indian Hospital jurisdictional issues. Councilor Thornton voiced concern for District 3 needing Marshal coverage. Councilor Walkingstick inquired about cross deputizing with the Oklahoma Highway Patrol. Councilor Hoskin Jr. requested information showing the number of times the Marshal Service patrols the low income properties.

Office of the Attorney General - Todd Hembree

Ms. Hammons commented they have been very busy. She announced Ms. Chrissi Nimmo is here and available to answer questions in regard to the South Carolina case. Ms. Hammons reminded everyone that they are bound by confidentially with regard to juvenile cases. She offered to answer questions from the report provided. Councilor Cowan Watts gave appreciation to Ms. Hammons and all of the work she and her staff have done over the past several years.

Election Commission -

Tax Commission - Sharon Swepston

*Ms.* Swepston announced effective February first they would only be open on Tuesday until 6:00 p.m. in the Tahlequah office instead of Tuesday and Thursday. Councilor Cowan Watts inquired about penalties for someone who fraudulently fronts a tag for someone or has a tag out of jurisdiction.

Self-Governance - Vickie Hanvey

Secretary of State, Charles Head, announced Ms. Hanvey is out on travel and that he would make sure that her report is submitted to this office within the next few moments.

Gaming Commission - Jamie Hummingbird

*Mr.* Hummingbird apologized for his report not making it in to the packet that it was submitted. He reported that as of the end of the calendar year 2010 the Nation under the term of the State compact has contributed in excess of one hundred million dollars in fees paid to the State. Councilor Cowan Watts inquired about the process for someone being banned from the casinos for a gambling issue.

Codification - Todd Hembree

*Mr.* Hembree announced he and *Mr.* Morton had a meeting with *Mr.* Jon James in regard to placing the files in one universal format. He commented if confirmed as the AG he would make this a top priority with the staff. He stated the project is 90% complete.

Youth Leadership Council - Mark Skinner

No one was present to report.

Registrar Citizenship Data Update - David Justice

Councilor Cowan Watts commented she had requested information be provided that is already compiled but has yet to receive. Mr. Head stated they met this week and the data is being compiled. Councilor Byrd moved to nominate Jodie Fishinghawk. Councilor Glory-Jordan seconded the motion with a friendly amendment to this resolution for the ending date to read August of 2015. Councilor Byrd accepted the friendly amendment. Councilor

Cowan Watts stated with it being in the Council Rules of Procedure for this position to be one year the agenda would have to be amended for consideration of Rules of procedure and then the amendment from one year to four years. Mr. Hembree agreed and read both the relevant portion of the Constitution and the Council Rules of Procedure. Councilor Glory-Jordan amended her friendly amendment to reflect a term of February 2012 to January 2013. Councilor Byrd accepted. Councilor Cowan Watts moved to nominate David Thornton. *Mr.* Hembree was once again requested to provide guidance as how to proceed with these nominations. He recommended to first determining if there are more than 8 who wish to be on the advisory board.

Mr. Hembree stated any person or Council member can attend but if a quorum were to manifest it would need to be broken.
