CALL TO ORDER

Chair Hoskin Jr. called the meeting to order at 1:20 p.m.

INVOCATION

Councilor Snell gave the invocation.

### APPROVAL OF MINUTES

Councilor Keener moved to approve the May 31st regular session minutes. Councilor Baker seconded the motion. The motion carried. Councilor Hargis moved to approve the May 31st Redistricting Subcommittee minutes. Councilor Walkingstick seconded the motion. The motion carried.

### REPORTS:

Marshal Service - Shannon Buhl

Mr. Buhl announced beginning next month they would include the in-house security on the monthly report. He offered to answer questions from the report provided.

Office of the Attorney General - Todd Hembree

Mr. Hembree gave an update on the recent Supreme Court decision pertaining to contract support costs. He also reported on the United Keetoowah Band's agreement with the State in regard to back fees and their application to place the land into trust where their casino now stands. He stated we have filed an objection to the application for placement of that land into trust. In regard to the Freedman case they

are filing their brief on the appeal for the District of Columbia case. An extension has been requested for the status conference in the Northern District case.

Codification - Todd Hembree

Mr. Hembree provided a handout of an estimate received from West. He gave a status update on the codification efforts. He stated he would be coming forward next month with a budget request at the Executive & Finance committee. Councilor Glory-Jordan inquired about an estimate for the pocket parts.

Councilor Garvin inquired about the Cherokee Fire Dancers in Colorado Springs.

Flection Commission -

Chairman Bill Horton reported the Administrative Procedures Act is under the advisement of their attorney at this time.

Tax Commission - Sharon Swepston

Ms. Swepston offered to answer questions from the report provided.

Self-Governance - Vickie Hanvey

Secretary of State, Charles Head reported in the absence of Ms. Hanvey. He stated he attended the Roads conference last week in Oklahoma City in regard to "Question 10". The change would result in significantly less funding for large land based tribes. Questions were asked about our State governments, other tribes and county commissioners. Councilor Cowan Watts requested clarification on an article in the Tulsa World regarding a joint venture with the City of Tulsa. Mr. Head reported in regard to the contract support decision referred to by the Attorney General, they are working to prepare draft claims and are working with the Health Department. He gave an update on the TAMS Title Project in Realty.

Gaming Commission - Jamie Hummingbird

Mr. Hummingbird offered to answer questions from the report provided. He provided updates on the Ramona, Ft. Gibson and Catoosa projects.

Tribal Youth Council - Danielle Culp

Ms. Danielle Culp introduced fellow Youth Councilor Brian Barlow. Mr. Barlow reported two representatives will be attending Unity and they will not be sending a representative to Tri-Council. They have been working toward implementing an online voting system for their Youth Council elections. Ms. Culp stated they are very interested in the redistricting process as they have currently set their guidelines for the five districts.

Registrar Citizenship Data Update - David Justice

Mr. Justice reported last month there were 451 address changes and 60 deceased notices submitted to Registration.

AN ACT AMENDING TITLE 13 SECTION 102 (a) and SECTIONS 304 (A)(b) and (c) OF THE CHEROKEE CODE ANNOTATED AND AMENDING LEGISLATIVE ACT 13-07 OF THE CHEROKEE NATION ADMINISTRATIVE PROCEDURE ACT

Councilor Cowan Watts commented there is a motion on the floor that was tabled which Councilor Keener made to include the Housing Authority. She provided a handout of outstanding issues. The Report was not provided from the Election Commission nor did the Attorney General's office provide the report showing the conflicts of the appeal processes. She voiced frustration for not receiving the items and for the non-compliance of the required agencies and requested direction of the Chairman. Chair Hoskin Jr. suggested the compliance issue be a separate agenda item for discussion from this proposed amendment to the Act.

Councilor Cowan Watts moved to table for one month. Councilor Keener seconded the motion. The motion carried.
