WHEREAS, the Principal Chief is authorized to select members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, Tonya Rozell is duly qualified to fill this board position vacancy pursuant to the bylaws of the Cherokee Nation Education Corporation.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Tonya Rozell is hereby confirmed as a Board Member of the Cherokee Nation Education Corporation Board of Directors for the term of four (4) years from February, 2010 until February, 2014.
