**WHEREAS**, the Principal Chief is authorized to select members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation;

**WHEREAS**, Tonya Rozell is duly qualified to fill this board position vacancy pursuant to the bylaws of the Cherokee Nation Education Corporation.


