**A RESOLUTION CONFIRMING THE RENOMINATION OF KYLE HASKINS AS A JUSTICE OF THE SUPREME COURT**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Supreme Court was created and authorized by Article VIII, Section 1 of the Cherokee Nation Constitution;

**WHEREAS**, the Principal Chief is authorized to select the justices subject to majority vote of the Council of the Cherokee Nation;


**WHEREAS**, the term of office #5 expires on December 31, 2008;

**WHEREAS**, Kyle Haskins is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.


**BE IT RESOLVED BY THE CHEROKEE NATION**, that Kyle Haskins is hereby confirmed as a Justice of the Supreme Court as authorized by Article VIII, Section 1 of the Cherokee Nation Constitution.




