# Program Highlights for March 2013

I. Indian Child Welfare Child Protective Services (CPS): There were 232 referrals of Cherokee child maltreatment from 22 Oklahoma Counties and 3 out of state. In March, there were a total of: 79 referrals for neglect only, 113 referrals for physical abuse, 88 substance abuse, and 40 referrals for sexual abuse.

- a. ICW Court Advocacy and Permanency (CAPS) Units: There are 1516 Cherokee children with assigned ICW workers. ICW workers were involved in 308 hearings regarding these children in March.
- b. ICW for Guardianships and Private Adoptions: There were 13 placements made in March. This last month we had 17 new homes open up as well as 6 homes close and 14 get recertified. There were a total of 35 children unable to be placed in March.
- c. **ICW Family Protection Services:** We have 50 children receiving services and 28 adults. This is a new program offering prevention and parenting services to families in the court system to assist in reunification with the children.
- d. **John Ketcher Youth Shelter:** 15 youth spent time at the John Ketcher Youth Shelter this last month.
  - i. **Juvenile first time offender program:** There were a total of 4 participants, 3 referrals, and I successful completion. We had I2 community service hours this month and 2 volunteers.
- e. **ICW Family & Employee Development:** We had 5 trainings with 25 attendees and 2 staff trainings during the month.
- 2. Child Support Services: The distribution for February was \$210,854. Child Supports Year-to-Date economic impact on our community is \$1,247,661. This is a \$7,215 increase from March 2012. There are a total of 2,800 child support cases and there are an additional 1488 that are either in transfer, new application status or are inactive status that our office must review on a daily basis. There were over 1351 contacts made with citizens needing assistance on their child support cases.
- 3. Family Assistance (Food Distribution): There were 8,479 individuals served in March. Year-to-Date Individuals Served: 55,640 throughout the 14 county jurisdictional boundaries.
  - a. **Family Assistance (Elderly Nutrition):** There were 3,730 hot meals served at Elderly Nutrition Sites and 1,031 Elder Nutrition Home Deliveries in March. Year-to-Date: Hot Meals Served 42,535; Year-to-Date: Home Deliveries: 14,447.
  - b. **Family Assistance (LIHEAP):** There were 15 households served for Heating Assistance during the month of March. LIHEAP YTD Served of all types; 2,452.

- c. Family Assistance (NAHASDA): There were a total of 176 Transitional, 40 Residential, and 26 Elderly households served this month within the NAHASDA Program and we have served 1,420 YTD households served.
- d. Family Assistance (General & Burial Assistance): 264 individuals were helped within General Assistance and YTD 1,532 has been served through this program. There were 18 Families helped within Burial Assistance in March and Year-to-Date we have assisted 194 families.
- e. **Elders in Need Program:** This program has been designed for our elders age 60 and older on fixed incomes who are in need of assistance. In the month of March we served a total of 952 Elders in our 14 county jurisdictions.
- f. **Elder Advocacy Program:** In the month of March we were able to serve 27 of our Elders with this program. Our YTD Elders In Need served is 109.
- 4. Child Care & Development (Child Care Centers): The Child Care Development Center is rated three stars, the highest possible in Oklahoma. There are a total of 126 children attending our Child Care Development Centers and there are 11 vacancies.
  - a. **CC&D** (Subsidy): 1517 Children received subsidy in March 2013 for the entire Cherokee Nation jurisdiction and over \$360,631.25 was distributed last month alone.
  - b. **CC&D** (Resource & Referral): There were 204 information calls received, 18 parent calls for referrals, 7 community events, 35 home visits for technical assistance, and 98 children receiving home visits. There were 7 trainings held in March.
  - c. **CC&D** (Licensing & Monitoring): Visits Made in March: 27 with a relative provider, 29 with child care centers, and 28 in child care homes.

#### 5. Special Programs -

- a. Office of Veterans Affairs: The Tribal Veteran's Representative received 25 calls for information and made 94 in person visits with Veterans in March. To insure we have a representative to assist the Veterans, the Veteran Affairs Office has increased their visits to our office until we can fill the vacancy of our Tribal Veterans Advocate. Trina Fisher (VA) will be on site (9:00-4:00) assisting any Veterans and/or their families. She will be here in the office on April 1st, 15th, and 29th. On April 29th John Cloud, who is an accredited Service Officer with the VA, will also be here and can assist with filing claims. In May, Trina and John will be here every Tuesday (7th, 14th, 21st, and 28th) to assist with the Veterans Office. Matt Tiger is here various times throughout the week and is reachable by phone (822-2563), if needed.
- b. Healing to Wellness Court Program: There were 13 youth participating in the voluntary Reclaiming Futures and Healing to Wellness Court Programs. There were 54 home visits with or about clients and 8 home visits concerning referrals in March. There were 23 drug tests administered, 1 call for resource information and 33 contacts regarding participant treatments this month.
- c. **Bright Futures (Truancy Prevention):** The Bright Futures program had 21 new cases worked in the month of March. We had I referral to the program last month and there

were 4 additional families agree to services. Last month there were 19 community participants.

### 6. Administration Initiatives:

- a. ICW held a Cherokee Children's Day at the Will Rogers Memorial in Claremore in March. Cherokee foster families attended with the children where we had Cherokee crafts and activities set up. There were approximately 75 attendees.
- b. Child Support co-sponsored the Region VI Tribal Roundtable with Osage Nation in March at the Hard Rock Casino in Catoosa. This Roundtable was an opportunity for Directors and staff to dialogue about issues pertaining to Child Support Programs.



#### Youth Development

Youth Activities: Total attendance at March youth activities was 100 youth, 19 parents/community members/B&G Club staff & 4 CYD staff.



• Kenwood has asked to put their youth activities on hold until they can find out if there is an interest in the community for them as it has been several months since any youth have showed up for activities.

- Greasy had a youth activity scheduled for Thursday, March 14<sup>th</sup>, we went to Greasy but no youth showed up, community organization felt this was because the Greasy School got a new superintendent and he had a free feed at the same time our youth activity was scheduled for. There were 2 community members and 4 CYD staff who showed up.
- Lost City had one youth activity on Thursday, March 21<sup>st</sup>, where they made beaded key chains and had 9 youth, 4 parents/community members and 4 CYD staff in attendance.
- Tailholt canceled the youth activity which was scheduled for Monday, March 25<sup>th</sup>, as there was a conflict with parent/teacher conferences at the school.
- Keys Boys & Girls club hosted a youth activity on Monday, March 4<sup>th</sup> where they made round reed baskets, there were 9 youth, 2 club staff and 4 CYD staff in attendance.
- Marryetta Boys & Girls club hosted a community youth event on Monday, March 11<sup>th</sup>, where the youth made beaded key chains. There were 17 youth, 2 B&G club staff members and 4 CYD staff members in attendance.
- Cave Springs Boys & Girls club did not host a community youth event in March due to Spring Break and school was out.
- Community Youth Development partnered with ICW for their spring break foster family day camp. We
  went to Will Rogers Museum and the youth made leather pouches. There were 23 youth, 7 parents & ICW
  staff and 4 CYD staff who worked with or made the leather pouch project.

Mailed & handed out 235 copies of flyers about April youth activities to residents, community organizations & participants in Cherokee Heights, Greasy, Lost City & Tailholt; also e-mailed flyers about April youth activities to the B&G clubs in Keys, Marryetta and Cave Springs for them to post.

## Community Work/Building Program

Indian Womens Pocohontas Club

- Vian Peace Center and Food Pantry used a portion of their grant money to purchase and install a walk-in freezer, increasing their capacity to provide food to their community.
- Orchard Road Community Outreach began work using their grant money to rebuild the parking lot to their Emergency Housing and Shelter, improving access to handicapped community members.
- Partnered with <u>Risk Management</u> in getting insurance to our 35 community organizations with buildings. COTTA provided: current insurance if any, types of events hosted in buildings, organizational contact information, building sizes, land ownership details, construction and maintenance costs
- Partnered with <u>Water and Sanitation</u> to provide information on Native American Fellowship's lack of adequate water supply to the building in South Coffeeville to develop a timeline for remodeling

- 5. Dahlonegah West- Designer: Holloway Updike & Bellen. R/W is complete with research of ownership. Met on site to discuss design concerns with the Engineer on July 26, 2012. Awaiting 30% set of plans.
- 6. Lyon Switch Designer: J. Shehi. Project was turned in for a 30% review on 8/20/12. Currently in check.
- 7. Malloy Hollow-Designer: D. Moore. 30% check complete. Designer is making revisions. Getting clearance from ODWC for design on their land.
- 8. North Salem (Bethel Road) Designer: Red Plains. It was decided to stay with the original alignment. Red Plains submitted 60% plans for check on 10/05/2012.
- 9. Smith Hollow Designer: Red Plains Engineering. Red Plains submitted revised 60% on August 22, 2012. Submitted RW documents on 8/17/12. R/W is currently checking the R/W exhibits and easements. The Categorical Exclusion was approved 11/27/12.

Petition to stop the road was submitted by landowners on November 14, 2011. Meeting with NACE on January 12, 2012 to discuss design options and landowner's petition against the project. 30% Preliminary plans have been resubmitted for review on December 26, 2012.
- 3. Dreadfulwater Road Designer: Andy Harris. 30% Plans were submitted for review on 02/14/2013.
- 4. Hulbert-Lost City Designer: Andy Harris. Hydrology Report was completed and the project has been imported into new software to allow the design to progress. Coordination with utility companies are underway. Project submitted for 60% check on 9/19/2012. HUB Engineering check was received on 3/18/2013. Designer is making revisions.
- 5. Lost City Road Designer: Holloway Updike & Bellen. Right of way research is complete. Preliminary survey complete. 30% set of plans received 12/27/2011 for review. 30% plan review was completed and submitted to HUB on October 16, 2012.
- 6. Tenkiller School –Designer: Red Plains. Plans are complete. Acquisition has started and R/W has 36 property owners signed out of 40 property owners at this time. R/W is acquiring R/W on the North and West side of the road project to help expedite the new waterline for that area. Received Archeological Report. Received clearance of Utility

- Easement for Electric to remain on South side of Road. No underground utilities will be allowed in the area of the gravesites. Archeoligies to be on site during excavation.

Public notice was published in the Delaware County Journal on January 20, 2013. Submitted plans to HUB Engineering for check and sign off by Engineer 04/2013.
- 6. Twin Oaks/Bull Hollow Road- Designer: D. Moore. Construction started August 1, 2012. Construction is 50% complete

#### **MAYES COUNTY PROJECTS:**

- 1. Cedar Crest Road Designer: Holloway Updike & Bellen. Rossco Construction has been selected as the contractor for this project. Contract for this project is \$2,244,835.46. Contractor early start began clearing on 7/9/2012 Construction is 65% complete -working on finishing agg.base and began placing asphalt.
- 2. Wickliffe Bridge (Salina/Kenwood)- Designer: Guy Engineering (Contracted through the county). Final Plans are complete. NEPA was approved 7/26/12. It was decided that the County Commissioner Mr. Ryan Ball will be acquiring the R/W. CN R/W has found in their research that Nancy Soldier's property is individual Restricted land. Guy Engineering has completed easements and exhibits using the research provided and returned documents to CN R/W for approval. CN R/W has completed the Restricted package and sent it to Real Estate Services to process to the BIA for their approval.

# c) CHEROKEE TRANSIT SYSTEM:

Cherokee Nation Transit has been Awarded \$350,000 for continuing transit services for FY 2013. This is \$100,000 short of last years transit award. Pelivan's Demand Response Service Agreement has been increased by \$50,000 using Tribal Transportation Program (TTP) funds.

# b. Notable events

- 1. The Oklahoma Attorney General's Office has begun disbursing financial settlements from the Oklahoma Mortgage Relief Settlement reached with the five big banks. The AG's Office received approximately 700 applications from Oklahomans who believed they were harmed by their lender; as of April 19th, 335 of those applications had been approved and financial settlements were being made. Financial settlements range from \$5,000 to \$20,000 with an average settlement of \$11,173. The remaining applications are still under review and updates will be provided as additional information is released.
- 2. The Free Tax Preparation Program began January 28th and ended April 15.

# 1,577 taxpayers used the Cherokee Nation VITA sites and received over \$2 million in refunds.

- 90 tax filers utilized the link on the Cherokee Nation homepage to file their taxes at no cost
- 288 filers were assisted with referrals to other VITA sites
- 376 of the 1,577 tax filers assisted did not use a VITA site last year; those filers paid \$33,825 last year to file their taxes
- Average adjusted gross income of families who utilized the VITA site was \$24,549
- Average refund received was \$1,665
- 3. Program to date, **418 families unable to obtain a non-predatory mortgage on their own** have completed self-sufficiency counseling and obtained a non-predatory mortgage.
- 4. YTD, Self Sufficiency staff members have worked with 25 families facing foreclosure. Staff helped 4 families save their home from foreclosure. 11 families are still in the process of trying to save their homes; 0 families have been referred to outside sources for assistance; 10 families have dropped out of the program.

- 1. Commerce Services is partnering with Career Services and Human Services to host the Information is Power Resource Fair each Friday in May from 9 am to 4 pm in the Tribal Complex. The resource fair will offer workshops throughout the day each Friday covering a range of topics that relate to an individual's financial health. Workshops include a Dave Ramsey Financial Peace University orientation, Negotiating with Creditors, Child Support Enforcement, Accessing Your Credit Report (hands on and ends with participants leaving with their credit report in hand), Payday Lending Dangers, How Money Works, Human Services Financial Assistance, Work Place Readiness, Dress for Success, Energy Conservation and Understanding Your Credit Score, Harvesting Traditional Foods and Eating Better While Spending Less.
- 2. Mortgage Assistance Program staff will be **meeting with realtors and mortgage lenders throughout Cherokee Nation** in the coming months to provide them with information about the Mortgage Assistance Program.
- d. Foreclosure information
  - 1. Cumulative MAP foreclosure rate is 3.2%; this figure is based on the active foreclosure filings for MAP all MAP distributions (FY05 FY13).
  - 2. The Federal Reserve periodically updates mortgage delinquency data by state and county; below is the most recent Serious Delinquency data, all mortgage types, available from the Federal Reserve.

# Oklahoma's Mortgage Settlement Update (this information is repeated from last month)

- Oklahoma's state government received \$18.6 million in settlement funds. Oklahoma's Attorney General has stated all settlement funds will go directly to victims of abusive foreclosure practices.
- Direct financial payments are being made to troubled borrowers and as of February 22<sup>nd</sup>, Oklahoma has paid 289 claims averaging \$11,090 each. It's important to note that these are cash payments to borrowers; consumer relief information reported by the five big banks in the national settlement include a combination of cash payments, debt forgiveness, mortgage modifications and mortgage principal reductions.
- \$1.275 million has been committed from the settlement funds to Legal Aid of Oklahoma to provide legal representation to lower income persons with foreclosure related legal issues and

\$15,000 to the Oklahoma Bar Association's Heroes program (<a href="http://www.okbar.org/heroes/">http://www.okbar.org/heroes/</a>) which provides legal assistance to Oklahoma veterans.

- \$50,000.00 has been committed to the Oklahoma Bankers Association to investigate and prosecute persons engaged in the unauthorized practice of law by falsely representing they can save Oklahomans from foreclosure.
- \$37,000.00 will be used to provide training to attorneys that will participate in a Voucher Program, which is intended to provide up to \$5,000 of legal assistance to families with foreclosure-related legal problems but who do not otherwise qualify for need-based assistance programs like Legal Aid. Voucher applications will be accepted through the summer of 2013, so it is unknown at this time exactly how much money will be used for that purpose.
- The Oklahoma Attorney General's Office is collecting data regarding refinances, lien forgiveness, modifications, principal reductions and forgiveness of arrearages provided to Oklahomans by the five big banks. The consumer relief provided to Oklahomans as a part of the banks' national settlement through December 2012 is below.
