WHEREAS, Cherokee Nation Administrative Appeals Board was created and authorized by Legislative Act 12-96;

WHEREAS, the Principal Chief, as representative of the Cherokee Nation, is authorized to select the members of the Board of Directors subject to a majority vote of the Council of the Cherokee Nation;

WHEREAS, Kenneth Limore is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Administrative Appeals Board.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Kenneth Limore is hereby confirmed as a Member of the Administrative Appeals Board for a term from October 1, 2009 expiring on October 1, 2013, as authorized by Legislative Act 12-96.
