WHEREAS, Hulbert Public School, located within the Cherokee Nation Reservation, operates on limited funds, and donating said item would benefit them greatly; and,

BE IT RESOLVED BY THE CHEROKEE NATION, that the Council of the Cherokee Nation authorizes the Cherokee Nation to donate these surplus items to Hulbert Public School as set out above.
