WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that has been deemed surplus:

2- Power Racks	2- Weight Bars	- Lt. Weight Dumbbells
1- Set of Free Weights	2- Weight Benches	
1- Set of Bumper Weights	- Weight Tree	

WHEREAS, the Cherokee Nation Warehouse desires to donate these items in "as- is" condition.


WHEREAS, Woodall Public School located within the Cherokee Nation jurisdictional boundaries, operates on limited funds and the donation of said items would benefit them greatly.




