# APPROVAL OF MINUTES

Councilor Baker moved to approve the April 22nd PAC Sub and the April 25th regular session minutes. Councilor Hargis seconded the motion. The motion carried.

### REPORTS:

Financial Report/Treasurer Report - Lacey Horn

Ms. Horn offered to answer questions from the report provided.

Cherokee Nation Businesses - Shawn Slaton

Mr. Slaton reported they had a good month in April. He provided updates on the current projects. They have six staff leaving tomorrow to assist in the tornado relief efforts in Moore. Councilor Byrd inquired about the public relations telling our Cherokee story. Councilor Thornton requested a status update on the feasibility

study in Sequovah county.

Career Services/Employment - Diane Kelley

Ms. Kelley provided updates on the Summer Youth Program and Day Training Program. She announced they are working to get the "Jobs Well Done" website back up but will be under a different name. The Building Trades group is doing a renovation and will be moving to the offices located next to the Attorney General. Councilor Thornton commented another employee is needed at Sallisaw Park. Councilor Fullbright commented she was impressed with the efforts at the GED graduation in Sallisaw.

Commerce - Anna Knight

Ms. Knight reported the gallery in the art center of the Cort Mall is now open. She offered to answer questions from the report provided.

### CEMETERY RESTORATION ASSISTANCE APPLICATIONS

Councilor Baker moved to approve. Councilor Byrd seconded the motion with the addition of McSpadden cemetery. Councilor Glory-Jordan requested the addition of Eureka and Henson cemeteries in Cherokee County. Councilor Walkingstick requested Holland cemetery be added. The motion for approval carried as amended.

### **COMMUNITY ASSISTANCE**

Councilor Glory-Jordan requested the American Legion Post 135 be for \$500 split 3 ways between herself and Councilors Walkingstick and Byrd rather than what is currently listed. She also requested the addition of the Owens Community Center for \$500 to be split between herself and Councilors Byrd and Walkingstick. Councilor Glory-Jordan announced the fund for the elderly subscriptions to the Phoenix is low and requested each give \$100 from their community assistance. She stated there would be a stipulation that the funds would be spent in the district in which the Councilor donated the funds.
