WHEREAS, Patsy Edgar is duly qualified to fill this board position pursuant to the Bylaws of the Cherokee Nation Community Association Corporation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Patsy Edgar is hereby confirmed as a Board Member of Cherokee Nation Community Association Corporation for the term of (3) years starting March 2008 until March 2011, as authorized by the Bylaws of Cherokee Nation Community Association Corporation.
