**WHEREAS**, it is beneficial for the Cherokee Nation to advance the quality of life of its citizens and for all peoples of Oklahoma; and,


**WHEREAS**, it is always important to recognize the achievements of our Cherokee Nation Youth who show great skills, accomplishments, and examples for others; and


