COUNCIL OF THE CHEROKEE NATION

A RESOLUTION CONFIRMING THE NOMINATION OF FARRELL PRATER AS A BOARD MEMBER OF THE CHEROKEE NATION REGISTRATION COMMITTEE

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

WHEREAS, the Cherokee Nation Registration Committee was created under A Article IV, Section 2 of the Constitution of 1999; and,

WHEREAS, the Principal Chief of the Cherokee Nation is authorized to appoint the Committee members subject to confirmation by majority vote of the Council of the Cherokee Nation; and,


WHEREAS, the term of the Registration Committee members is concurrent with the Principal Chief's term; and,

WHEREAS, Farrell Prater is duly qualified to fill this vacancy pursuant to Article IV, Section 2 of the Constitution of 1999.


BE IT RESOLVED BY THE CHEROKEE NATION, that Farrell Prater is hereby confirmed as a member of the Cherokee Nation Registration Committee and will serve a term from April 2025 until August 14, 2027.




