WHEREAS, the Principal Chief is authorized to select the members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation; and

WHEREAS, AMBER LYNN GEORGE is duly qualified to fill this board position, Seat Eleven (11) pursuant to the Bylaws of the Cherokee Nation Foundation;

BE IT RESOLVED BY THE CHEROKEE NATION, that AMBER LYNN GEORGE is hereby confirmed as a Board Member of Cherokee Nation Foundation, Seat Eleven (11) for the term May, 2013 expiring May, 2017, as authorized by the Bylaws of Cherokee Nation Foundation.
