BE IT RESOLVED BY THE CHEROKEE NATION, that Adolph Lechtenberger is hereby confirmed as a member of the Board of Directors of Cherokee Nation Businesses, LLC, and its successors, for a term September 30, 2009 that expires September 30, 2012.
