WHEREAS, the appointment of the Board of Directors in Legislative Act 36-89 was nullified by JAT 97-01;

WHEREAS, the appointment of members of the Board, replacing that portion of #36-89 previously addressing the appointment of said Board members, is provided for in Legislative Act 4-02;

WHEREAS, a vacancy exist on the Board of Directors and Lorilee Smiley has been selected to be nominated by the Principal Chief;

WHEREAS, Lorilee Smiley is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Lorilee Smiley is hereby confirmed as a Board Member of the Cherokee Nation Economic Development Trust Authority Board of Directors for the term of one (1) year from July 2009 until July 2010.
