2. Executive Director's Report - Melanie Knight

Ms. Knight provided a handout of funded applications for Higher Education for this fall broken down by District. Councilor Glory-Jordan inquired if all applications that met the deadline and were complete would be funded. Ms. Knight stated that was correct. They are funding part time students at a lesser amount. She is in the process of reviewing some hardship cases and some special consideration applications. She reported if a student is funded at the full time rate for the fall and drops to part time they will not receive the full funding for the spring. Councilor Glory-Jordan inquired if a letter was being sent out with this explanation. Ms. Knight stated the guidelines are sent with the award letter. Councilor Glory-Jordan requested a separate letter be sent out specifically stating the reason for the reduced amount. Ms. Knight stated they could send out a separate letter. Councilor Cowan Watts voiced concern for the new Sequoyah High School building originally for math and science now seems to be moving toward math, arts and sports. Ms. Knight stated this is in the very preliminary stages of planning and will take the concerns back to the committee.
