# RESOURCE COMMITTEE LEGISLATIVE CONFERENCE ROOM February 12, 2007 4:09 p.m.

#### CALL TO ORDER / INVOCATION / ROLL CALL:

Chair Martin called the meeting to order. Council member Shotpouch gave the invocation. Roll was called and a quorum was established.

#### APPROVAL OF MINUTES:

Councilman Jack Baker made a motion to approve the minutes of the January 22<sup>nd</sup> regular session. Council member Shotpouch seconded the motion. Motion carried.

#### **REPORTS:**

#### Natural Resources:

Mr. Todd Enlow reported in the absence of Ms. Angela Drewes. He stated since January the 22<sup>nd</sup> they continue to work on assistance regarding disaster relief. They had 75 inquiries for the month. The Job Corp trucking company expansion is ongoing. They are working diligently with FEMA to present their case for individual assistance for families affected by the storm. Councilman Keen inquired if the At Large citizens could also receive storm relief assistance. Mr. Enlow stated they are in the process of looking at the flexibility of the funds set aside. Councilman Keen inquired if the At Large applications for assistance taken so far had been denied. Mr. Enlow stated they had been but they have the applications and will be reviewed once again. Chair Martin inquired about he annual meeting at the Dahlonegah facilities in April. Mr. Enlow stated they would get everything together and make an announcement next month. Council member Shotpouch gave appreciation for Mr. Enlow's efforts during the storm.

## Real Estate Services:

Ms. Linda Donelson stated Real Estate Services has received and returned 804 phone calls, had 85 individual clients in the office, completed 29 site inspections, completed 5 probate inventories with an additional 66 probate inventories on 1 tract of land. They received 32 approved grazing leases, 18 land assignments, 7 hunting leases, 20 right of way appraisals, 14 jurisdictional calls, 4 quiet title, 4 will interviews, as well as turned in the first quarter reporting to the bureau. Some of the grazing tracts received storm damage therefore they are requesting assistance from FEMA. They assisted the Human Services Department with paperwork to vacate the 40 acres adjoining the Markoma property. They purchased the Court Mall containing 2.57 acres on the 29<sup>th</sup> of January. The barber shop is the only lessee on the property. They also purchased the church next to the Park Hill Post Office containing .8 acres or 3 lots. She announced they attended a NAVE conference in Houston. Two of the oil and gas companies attending the conference showed interest in the Chilloco property. Councilman Anglen inquired about the status of the Ramona property. Ms. Donelson stated the CNE board is close to approving a deal.

# Roads & Transportation:

Mr. Michael Lynn. He provided the following update of IRR roads:

- > Cedar Crest Road and Bridge They are working on acquiring right of ways
- ➤ Daytown Dry Creek out for bid this Thursday
- > Red Barn Road -utilities problems with AT&T, weather has set behind
- $\triangleright$  Fairview Euche phase II 40 50% cleared
- > Rice Woodard in right of way acquisition phase.
- > Twin Oaks Bull Hollow the bridge is under construction deck should be poured this week.
- ➤ Kenwood Road 50% designed. Trying to determine a process for the 6 bridges on the project.
- ➤ Stick Ross Loop 50% designed

Mr. Lynn announced there are 5 motor fuel/motor vehicle projects going to Executive and Finance Committee this month: 2 in Cherokee County, 2 in Delaware County and 1 in Craig County totaling just over \$640,000.00.

He requested the IRR Inventory update resolution being presented to this committee in March be forwarded to Full Council the same night.

Mr. Lynn announced he had spoke to the new county commissioner in regard to the Stan Watie Road extension and has been told they hope to have it complete by May.

Chair Martin requested the introduction of an audience member. The gentleman introduced himself as Ben Walkingstick.

# Facilities:

Mr. Todd Enlow reported in the absence of Mr. David Roberts. Mr. Enlow stated they continue to work on issues sustained during the ice storm. They recently bid out the generator for the complex. They have received a successful bid and expect to have the generator from the manufacturer in 15 weeks. They have also submitted an RFP for the air conditioner on the financial resource building.

# **NEW BUSINESS:**

1. A Resolution Authorizing Cherokee Nation Environmental Programs to Submit a Formal Grant Application to the U. S. Fish and Wildlife Service for a Tribal Wildlife Grant. Ms. Jeannine Hale stated this grant is for \$86,000.00 with no match. The purpose for this grant is to do a survey of the American Burying beetle. Every time they have to do an environmental review for a housing or construction project they have to stop in the middle to do this survey.

Councilman Bill John Baker made a motion to approve. Council member Conner seconded the motion. Motion carried.

A Resolution Authorizing a Grant of Easement for Right of Way Over Tribal Trust Land in Adair County Known as CMS-32 Between Cherokee Nation and Fred and Ronda Holtz, 12 W Oak, Stilwell, OK 74960 for Access. Ms. Linda Donelson announced this is for an easement for right of way in Adair County. The Holtz are not Cherokee citizens but have been living next to this tribal tract since the 1950's. We need to give them legal access. Councilman Garvin made a motion to approve. Council member Cowan Watts seconded the motion. Motion carried.
