**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Tax Commission Board of Commissioners was created and authorized by Title 68 §11 of the Cherokee Nation Code Annotated;


**WHEREAS**, Scott Gregory's term expires October, 2009 as a Commissioner of the Cherokee Nation Tax Commission and is nominated for reappointment as authorized by Title 68 §11 of the Cherokee Nation Code Annotated; and

**WHEREAS**, Scott Gregory is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.


**BE IT RESOLVED BY THE CHEROKEE NATION**, that Scott Gregory is hereby confirmed as a Commissioner of the Cherokee Nation Tax Commission for the term of three years effective October 2009 through October 2012 as authorized by Legislative Act 1-90, the Act of February 10, 1990.
