WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Tax Commission Board of Commissioners was created and authorized be Title 68 §11 of the Cherokee Nation Code Annotated;

WHEREAS, Seat 3 of the Cherokee Nation Tax Commission Board of Commissioners is currently vacant;

WHEREAS, Steve Wilson is duly qualified to fill this vacancy, pursuant to the laws of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that the Tribal Council of the Cherokee Nation hereby confirms Steve Wilson as a commissioner of the Cherokee Nation Tax Commission, with a term beginning February, 2020 and ending February, 2023.
