OLD BUSINESS

LIHEAP PROGRAM (continued discussion and possible action)

Ms. Merriman announced Mr. Jerry Snell was unable to attend this meeting. She did say she had spoken with him and he has talked to two of our largest area propane suppliers. He learned the difference in price this year was pretty small this past year. Mr. Snell is now in the process of compiling information from 2006 and 2007 from all heating sources. Ms. Merriman reminded the Council if pellets are purchased in the summer when the cost is cheaper they must then be stored then transported when needed which both are costly. Chair Buzzard inquired if she had met with Callie Catcher in regard to forward funding. Ms. Merriman stated it was her understanding after talking to Ms. Catcher that forward funding is not a good option. Councilor Bill John Baker expressed wishes to go ahead and fund \$200,000 for propane for the poor and elderly. He made a motion to move from this committee to executive and finance \$200,000 to supplement LIHEAP to purchase summer propane. Councilor Thornton seconded the motion. Chair Buzzard stated there is still time for research. Councilor Bill John Baker reminded the committee in the past when additional funds were appropriated the Federal government gave a supplement. Ms. Merriman stated she would research further and continue to gather additional information. Councilor Cobb stated this is good sound business thinking. He suggested tabling this discussion to allow time to put together a business plan. Councilor Bill John Baker stated he isn't opposed to tabling the discussion to obtain additional information. They won't need to purchase the propane till summertime.

Councilor Thornton announced he had just called Liberty Propane and was told last summer propane was \$1.70 a gallon and in November it went to \$2.25.

Councilor Jack Baker moved to table to gather additional information.

Councilor Cowan Watts seconded the motion. Motion carried.

EMERGENCY HOUSING PROGRAM (continued discussion and possible action)

Mr. Southerland stated as of yesterday they have spent \$45,000 since October 1st with \$150,000 remaining. At the present rate of spending he doesn't feel there is a need for additional funding at this time. Chair Buzzard requested Mr. Southerland keep the Council appraised of the funding balances.
