WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation W.W. Hastings Hospital has the following equipment in its inventory that has been deemed surplus:

85 IV Pumps

WHEREAS, the Cherokee Nation W.W. Hastings Hospital desires to donate this equipment in "as- is" condition.

WHEREAS, the Northeastern Health System located within the Cherokee Nation jurisdictional boundaries, operates on limited funds and the donation of this equipment would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that the Tribal Council hereby authorizes Cherokee Nation W.W. Hastings Hospital to donate this equipment to the Northeastern Health System in Cherokee County as set out above.
