WHEREAS, the Cherokee Nation Businesses, LLC is tribal Limited Liability Company created and authorized under the Cherokee Nation Limited Liability Company Act; and,

WHEREAS, the Principal Chief, as representative of the Cherokee Nation, is authorized to select the members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation; and.

WHEREAS, Barry Reynolds is duly qualified and should be reappointed to Seat 1 (one) as a member of the Board of Directors of Cherokee Nation Businesses, LLC, and its successors, for a term of five (5) years.

BE IT RESOLVED BY THE CHEROKEE NATION, that Barry Reynolds is hereby confirmed as a member of the Board of Directors of Cherokee Nation Businesses, LLC, and its successors, filling seat 1 (one), for a term that expires August 31, 2030.
