WHEREAS, the Cherokee Nation Gaming Commission was created and codified under Title IV of the Cherokee Nation Code Annotated;

WHEREAS, the Principal Chief is authorized to select the members of the Commission subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, the term of office of a Commissioner expires September 2010;

WHEREAS, Shannon Fisher is duly qualified to fill this vacancy pursuant to Section 12, Chapter 2, Title IV of the Cherokee Nation Code Annotated.

BE IT RESOLVED BY THE CHEROKEE NATION, that Shannon Fisher is hereby confirmed as a Commissioner of the Cherokee Nation Gaming Commission for the term of (3) years from September 2010 until September 2013 as authorized by Section 12, Chapter 2, Title IV of the Cherokee Nation Code Annotated.
