WHEREAS, the Principal Chief is authorized to select the members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation; and

WHEREAS, Gloria Sly is duly qualified to fill this board position, Seat 3 (three) pursuant to the Bylaws of the Cherokee Nation Foundation;

BE IT RESOLVED BY THE CHEROKEE NATION, that Gloria Elaine Sly is hereby confirmed as a Board Member of Cherokee Nation Foundation, Seat 3 (three) for the term February, 2013 expiring February, 2017, as authorized by the Bylaws of Cherokee Nation Foundation.
