WHEREAS, the Principal Chief is authorized to select the members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, Deborah Scott is duly qualified to fill this board position pursuant to the Bylaws of the Cherokee Nation Community Association Corporation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Deborah Scott is hereby confirmed as a Board Member of Cherokee Nation Community Association Corporation for the term of three (3) years commencing April 2011 until April 2014, as authorized by the Bylaws of Cherokee Nation Community Association Corporation.
