CALL TO ORDER

Chair Lay called the meeting to order at 3:10 p.m.

INVOCATION

Councilor Snell gave the invocation.

APPROVAL OF MINUTES

Councilor Baker moved to approve the September 15th regular session minutes. Councilor Hargis seconded the motion. The motion carried.

REPORTS:

1. Human Services Department - Marsha Lamb

Ms. Lamb gave appreciation to everyone who attended the Warrior Veteran's send off. They are currently making plans for the Veteran's day events on the 10th of November over at the Center. This year they are taking the wood and propane applications for LIHEAP first as it is a longer process than electric and natural gas. Councilor Walkingstick commented CNB has cut five ricks of wood and is looking for people in need. Councilor Buzzard commented on the wonderful trip with the WWII Veterans and inquired if there would be another trip next year. Councilor Hargis inquired if we have wood stoves to give out.

2. Community Services - Ron Qualls

Mr. Qualls commented a resolution is currently in the routing process to transfer property to a family. Councilor Buzzard inquired about rural water at Oaks. Mr. David Pruitt gave an update on the rehab program. Councilor Buzzard inquired about bidding those remaining jobs. Councilor Cowan Watts inquired about assisting in getting the jobs bid.

3. Housing Services - Gary Cooper

Mr. Cooper reported all of the area offices are open or will soon be open. He announced this semester they are assisting the most college students with housing since the program has been re-opened. Councilor Byrd inquired how long the program had been reinstated. Councilor Cowan Watts requested clarification on the number of homes built. Councilor Buzzard requested clarification for Delaware County. Councilor Hargis inquired about the 20 homes in Adair County.

4. Roads & Transportation - Michael Lynn

Mr. Lynn gave an update on their three current projects; Wickliffe Creek Bridge in Mayes County, the Jay Kenwood Bridges in Delaware County and the Sequoyah High School intersection here in Cherokee County. Councilor Walkingstick inquired about the gas line issue on Tenkiller Road. Councilor Buzzard requested they review the road to the Bull Hollow Shop to see about listing it as a priority.

She gave a list of special items of need and provided ideas of how to gather items by having donation drives. Councilor Byrd inquired about coordinating other trees. Councilor Coates inquired when the items are due

back. Councilor Glory Jordan proposed the Council double the number of angels we help from 17 boys and 17 girls to 34 boys and 34 girls. The motion to increase to a total of 68 angels passed with no opposition.
