WHEREAS, Adolph Lechtenberger is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Entertainment, LLC, and its successors, for a term that expires September 30, 2012, and pursuant to the attached Memorandum of Action of the Principal Chief of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Adolph Lechtenberger is hereby confirmed as a Board Member of the Cherokee Nation Enterprises, LLC, and its successors, for a term that expires September 30, 2012.
