**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, Cherokee Nation Entertainment, LLC, is a tribal Limited Liability Company created and authorized by the Cherokee Nation Limited Liability Company Act;


**WHEREAS**, the Principal Chief, as representative of the Cherokee Nation, is authorized to select the members of the Board of Directors subject to a majority vote of the Council of the Cherokee Nation;

**WHEREAS**, Adolph Lechtenberger is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Entertainment, LLC, and its successors, for a term that expires September 30, 2012, and pursuant to the attached Memorandum of Action of the Principal Chief of the Cherokee Nation.


**BE IT RESOLVED BY THE CHEROKEE NATION**, that Adolph Lechtenberger is hereby confirmed as a Board Member of the Cherokee Nation Enterprises, LLC, and its successors, for a term that expires September 30, 2012.
