

II. Program Highlights

a.) Motor Vehicle

- 1. Year to Date Motor Vehicle revenue for FY18 compared to FY17 as of December 31st 2017 & December 31st 2016, had an overall increase of 11.61%.

II. Program Highlights

a. Self-Governance Advisory Committee (SGAC) (DOI) meetings and Tribal Self-Governance Advisory Committee (TSGAC) (IHS)

The Self Governance Director and General Counsel attended the quarterly meetings of the SGAC and TSGAC on January 23 through 25. DOI topics of discussion included status update on DOI reorganization, move of OST back to BIA with the exception of Appraisals which is being moved to another Bureau within DOI, committing Indian issues within DOI's Strategic Plan, imposing 638 on USDA and expanding Self-Governance into USDA through the Farm Bill, status on DOT Negotiated Rule Making, legislative updates, FY 2018, 2019 and 2020 budget status and updates. IHS topics discussed included the status of the IHS Director nomination/hearings, IHS strategic plan workgroup progress, Sanitation Deficiency System Guidance consultation, level of need funded workgroup process, CMS Medicaid work requirements, requirement on Tribal Consultations, payment deadline for Self-Governance funds, budget caps and sequestration impact on tribes, and reauthorization of Special Diabetes Program.

b. 2020 Budget Formulation and Unfunded Obligations Survey

The second part of the 2020 budget formulation process, Unfunded Obligations Survey, was completed and submitted to the BIA. The BIA consolidated all of the Tribes within the Region's unfunded Obligation Report and submitted to Headquarters. The Self Governance Director and General Counsel attended the Region's annual budget meeting on February 1. The top ten priorities as submitted by the tribes within the Region in order of priority are Indian Child Welfare Act, Social Services, Criminal Investigations and Police Services, Aid to Tribal Government, Welfare Assistance, Agriculture Program, RES Program, Tribal Courts, Scholarships and Adult Education, and Natural Resources.

c. USDA, Local Emphasis Area

The USDA notified us that our request for a Local Emphasis Area Designation for the Nation's Kenwood property where the loblolly pines are located has been approved and that we have been awarded \$100,000.00 to thin the pines in accordance with our Forest Management Plan approved by the BIA.
