REPORTS:

Cultural Tourism - Molly Jarvis

Mr. Travis Owens reported in the absence of Ms. Jarvis. He gave highlights from the report and announced on December 13th from 4:00 to 6:00 they will have Christmas on the Square here in Tahlequah, this event takes place just prior to the Christmas parade. He offered to answer questions. Councilor Shaw requested a quicker or earlier notification of upcoming events. Councilor Crittenden requested contact information on the mentorship program. Councilor Buzzard inquired if the construction fence has been taken down at the Saline Courthouse. He also inquired about the painting at Oak Hill Piney. Councilor Shambaugh expressed the wishes of the Oak Hill Piney community for the painting to remain within their community. Councilor Deere inquired

about the Route 66 signage and joining in the efforts. Councilor Buzzard requested an old historical building in Bull Hollow be considered for preservation. Chair Vazquez applauded them for the efforts at the Cherokee Art Market as it gets better and better each year. Councilor Legg inquired about our participation at the Gathering Place. Councilor Shambaugh requested a time to go view the Beck's Mill.

Cherokee Nation Language Program - Roy Boney

Ms. Sixkiller gave an update of the Speakers Bureau and the Consortium meetings. The Speakers Bureau is tomorrow with their annual thanksgiving meal. Councilor Byrd inquired about the officers of the Speakers Bureau and Consortium. He commented the song discussed during the last meeting has been written down and recorded. Mr. Boney announced Friday the DD Ethicon Church here in Tahlequah is hosting a Cherokee speaking luncheon. Rogers State University TV will be airing forty-eight fifty minute episodes of Cherokee One beginning January 13th. They were invited in October to visit the Google headquarters in California to discuss their partnership and its continuation. Councilor Austin requested an update on the gaming project with RSU. Councilor Shaw inquired about a foreign exchange type language program. Councilor Nofire inquired about the Cherokee Film and content for kids. Councilor Shambaugh commented on a teacher in Kansas doing Cherokee classes on her own time. Mr. Boney announced he was nominated by Google to present at a conference in Paris, France on Cherokee language technology.

Mr. Stretch gave highlights from the report provided and offered to answer questions. Chair Vazquez inquired about the teacher and schedule for the history course. Councilor Buzzard requested clarification on the report pertaining to the number of speakers.
