A RESOLUTION AUTHORIZING CHEROKEE NATION WAREHOUSE TO DONATE SURPLUS ITEMS TO BRAGGS PUBLIC SCHOOLS

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that has been deemed surplus:

CN (CCO) Vehicle #1FBAX2CM2GKA48869 2016 Ford Transit Van T-350


WHEREAS, the Cherokee Nation Warehouse desires to donate these items in "as- is" condition.




