### A RESOLUTION ADOPTING REVISIONS TO THE 2008 INDIAN HOUSING PLAN RELATED TO ARRA/STIMULUS FUNDING

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation has received Native American Housing Assistance and Self-Determination funds through the American Recovery and Reinvestment Act of 2009;

WHEREAS, the use of the NAHASDA funds were incorporated into the 2008 Indian Housing Plan by Resolution No. 23-09 on March 16, 2009 and the IHP now needs to be amended;

WHEREAS, the needed changes are incorporated on "Attachment 1".

**BE IT RESOLVED BY THE CHEROKEE NATION,** that the changes to the 2008 IHP are approved to be incorporated in a revised 2008 IHP, along with any conforming changes directly related to such changes and no others, and submitted to the Department of HUD.

(Council Resolution Regarding 2008 IHP Changes (ARRA/Stimulus Funding)

#### Changes to Current 2008 IHP

- #1 Objective 1A will change the number of units modernized from 500 to 902 individual units and the number of LR/MH projects from 20 to 12.
- #2 Objective 2D will change from the rehabilitation of 103 homes to 150 and the amount of direct costs spent per unit from approximately \$30,000 each to approximately \$37,000 each
- #3 Administration funds will be increased from \$221,212 to \$293,812 and added as part of "Objective 6A"
- #4 Anticipated program income is increased from \$21,615 to \$187,852
- #5 The percentage of ARRA/Stimulus funds to be used for administration changes from 1.86% to 2.44%.
- #6 Rehabilitation funds will be increased from \$5,504,097 to \$5,597,734

(The changed numbers, both objectives and dollar amounts, will require conforming changes to other tables and schedules in the IHP. No other changes to the IHP will be made.)
