WHEREAS, the term of the Registration Committee members is concurrent with the Principal Chief's term;

WHEREAS, Marybelle Chase is duly qualified to fill this vacancy pursuant to Article III, Section 2 of the Constitution of 1975.

BE IT RESOLVED BY THE CHEROKEE NATION, that Marybelle Chase is hereby confirmed as a member of the Registration Committee.
