CALL TO ORDER

Chair Snell called the meeting to order at 5:03 p.m.

NEW BUSINESS

3. TMP-305 CHEROKEE NATION WASTE MANAGEMENT - STATUS REPORT

Councilor Hargis stated the landfill was given funding several months back and was requested to come forward and provide a status report within six months. Ms. Fan Robinson provided an update of the progress the current board has done over the past year. She announced they plan to have another community meeting in September and extended an invitation to the Council to attend. She announced they will need funding to operate and get equipment. Councilor Glory Jordan inquired about the lease purchase agreement for the equipment delivered several months ago. Councilor Hargis inquired if they have any new contracts for trash. Councilor Glory Jordan commented they passed a budget for \$850,000 to run on for the year, acquire new contracts, and get a lease purchase agreement on the equipment. She inquired if they needed assistance working out the lease purchase agreements.
