### APPROVAL OF MINUTES

Councilor Vazquez moved to approve the August 14th regular session minutes. Councilor Baker seconded the motion. The motion carried.

# REPORTS:

Marshal Service - Shannon Buhl

Marshal Buhl offered to answer questions from the report provided. He handed out a page of a national officers magazine with two of our marshals on the cover. Chair Byrd commented on his visit to the National Marshal Museum ground breaking in Ft. Smith.

Office of the Attorney General - Todd Hembree

Attorney General Hembree reported they are waiting on a decision on the Freedman case. All of the briefings and finding of facts have been submitted in the UKB two acre case regarding gaming and they now await a decision. The Information Officer applications have been received and are currently being reviewed. He reported the

FOIA report is available on their website. The gaming amendments recently passed by this Council have been submitted to the NIGC. He announced he will be speaking at the Leadership Oklahoma Conference tomorrow. Councilor Keener inquired as to when the gaming changes would take effect. Councilor Walkingstick inquired about a timeline on the UKB case.

Codification - Todd Hembree

Codification is complete and they are waiting on the final drafts from West. We are expecting printing to begin in October.

Tax Commission - Sharon Swepston

Mr. Andy Quetone reported in the absence of Ms. Swepston. Councilor Keener inquired about the downturn in the revenue. He also inquired about if they are moving forward with the new tag office/visitor center in Catoosa. He gave an update on the new Sallisaw and Tahlequah locations.

Self-Governance - Vickie Hanvey

Ms. Hanvey announced they received their direct support cost amendment which was finalized and negotiated last week. She reported they have been working with the BIA and the Office of the Special Trustee to update their agreement on the old IIM program now known as the Beneficiary Process program.

Gaming Commission - Jamie Hummingbird

Mr. Hummingbird recognized Kelly Myers for being named as of one Indian Americas forty under forty. Councilor Baker commented the gaming report is missing. He provided an oral report and stated the actual report would be sent by email.

Human Resources - Nason Morton

Mr. Morton gave an update on the substitute teachers at Sequoyah. He also provided an update on the Stilwell CDC as requested. He provided an update on the electronic EAN system. Councilor Walkingstick inquired about a job description for a Chaplin. Councilor Cowan Watts inquired about the process for job location at Cherokee Nation and Career Services and a point of contact.
