A RESOLUTION CONFIRMING THE REAPPOINTMENT OF ANTHONY YATES AS A COMISSIONER OF THE HOUSING AUTHORITY BOARD OF THE CHEROKEE NATION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

WHEREAS, the Cherokee Nation has exclusive tribal jurisdiction over the Cherokee Nation Reservation, the geographic scope of which is defined in federal and Cherokee Nation law; and,

WHEREAS, the Housing Authority of the Cherokee Nation was created and authorized by Section 1057 of Title 63 of the Oklahoma Statutes; and,

WHEREAS, Anthony Yates is duly qualified to fill this position pursuant to the Bylaws of the Housing Authority of the Cherokee Nation; and,

WHEREAS, Anthony Yates is hereby nominated for reappointment as authorized by Section 1058 of Title 63 of the Oklahoma Statutes and the Bylaws of the Housing Authority of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Anthony Yates is hereby confirmed as a Commissioner of the Housing Authority Board of the Cherokee Nation as authorized by Section 1058 of Title 63 of the Oklahoma Statutes and the Bylaws of the Housing Authority of the Cherokee Nation for a term of three (3) years beginning April 2025 and ending April 30, 2028.
