# A RESOLUTION CONFIRMING THE NOMINATION OF TINA GLORY JORDAN TO THE SUPREME COURT OF THE CHEROKEE NATION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, Justices of the Supreme Court are authorized in Article VIII Section 1 of the Constitution of the Cherokee Nation;

**WHEREAS**, according to Article VIII Section 2 of the Constitution, the Justices shall be appointed by the Principal Chief and confirmed by the Council of the Cherokee Nation;

WHEREAS, the Principal Chief has appointed Tina Glory Jordan as a Justice of the Supreme Court of the Cherokee Nation, Seat 2, to fulfill the duties of Justice as articulated in Article VIII of the Constitution;

WHEREAS, Tina Glory Jordan is duly qualified.

**BE IT RESOLVED BY THE CHEROKEE NATION** that Tina Glory Jordan is hereby confirmed as a Justice of the Supreme Court of the Cherokee Nation, Seat 2, to fulfill the duties of Justice as specified in Article VIII of the Constitution of the Cherokee Nation for a term beginning August 2023 to December 2032.
