### **A RESOLUTION AUTHORIZING THE DONATION OF SURPLUS EXERCISE EQUIPMENT FROM SEQUOYAH SCHOOLS TO BELFONTE ELEMENTARY SCHOOL**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;


**WHEREAS**, Cherokee Nation Sequoyah Schools has installed new exercise equipment and will surplus the old equipment and Belfonte Elementary can utilize the equipment which has been surplus;

**WHEREAS**, Cherokee Nation Sequoyah Schools recognizes the need to be resourceful with our Nation's assets and assist our public schools when possible;


**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council hereby authorizes the donation of the surplused exercise equipment to Belfonte Elementary School.


