### b. State of the Youth Council

The selection process for the 2012 youth council did not occur due to the 2011 council's determination to change their terms back to 2 years to align with Unity's and NCAI's calendars. The 2011 council was unable to ratify their bylaws by the end of their term so a special committee is being assembled to review the situation and determine how the youth council can be reorganized. The Cherokee Nation Youth Leadership Council is currently under a reorganization to review and evaluate the current Cherokee Nation Youth Leadership Council By-Laws and to make sure that the Youth Council is adhering to Resolution #80-89, "The Endorsement of the Establishment of a Tribal Youth Council." We are looking into the current function and purpose of the Youth Council and are devising a strategy that will allow the Youth Council to function in the best interest of the Youth and the Cherokee Nation. We hope to come to a swift, effective, and efficient solution to our current reorganizational issues. We are still broadening and expanding our voice on the National level and looking into the possibility of sending a youth delegation to represent Cherokee Nation at the United National Indian Tribal Youth Mid-Year Conference in Washington D.C.
