WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation desires to assist in providing a source of clean drinking water to our communities;

WHEREAS, the Cherokee Nation has the following items that has been deemed surplus, namely:

1. John Deere 310D Backhoe Serial # TO310DA776992

WHEREAS, Cherokee County Rural Water District # 8 is a non-profit rural water district that provides water to the Citizens of Briggs, OK,


WHEREAS, Cherokee County Rural Water District # 8 desires to obtain a backhoe in order to become more self-reliant in the operation of their district.
