**A RESOLUTION AUTHORIZING CHEROKEE NATION
WAREHOUSE TO DONATE SURPLUS ITEMS TO
VANN'S LAKE BAPTIST CHURCH**

WHEREAS, the Cherokee Nation, since time immemorial, has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following item in its inventory that have been deemed surplus:

CN item #106134 72" Heavy Duty Hustler Excel Mower


The Cherokee Nation Warehouse desires to donate this item in "as-is" condition.




