**COUNCIL OF THE CHEROKEE NATION**

**A RESOLUTION CONFIRMING THE RENOMINATION OF DERRICK VANN AS  
REGISTRAR OF THE CHEROKEE NATION**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic continual government-to-government relationship with the United State of America;

**WHEREAS**, the Cherokee Nation Registrar was created under Article IV, Section 2 of the Constitution; and

**WHEREAS**, the Principal Chief is authorized to appoint the Registrar, subject to confirmation by majority vote of the Council of the Cherokee Nation; and

**WHEREAS**, the term of office for the Registrar is concurrent with the Principal Chief's term; and

**WHEREAS**, Derrick Vann is duly qualified to fill this position and should be appointed as Registrar of the Cherokee Nation Registration Committee.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Derrick Vann is hereby confirmed as the Registrar of the Cherokee Nation Registration Committee for a term beginning August 2023 to August 2027.


**CERTIFICATION**

The foregoing resolution was adopted by the Council of the Cherokee Nation at a duly called meeting on the 31<sup>st</sup> day of August, 2023, having 16 members present, constituting a quorum, by the vote of 16 yea; 0 nay; 0 abstaining.


