CALL TO ORDER

Chair Taylor called the meeting to order at 3:00 p.m.

**INVOCATION** 

Councilor Warner gave the invocation.

APPROVAL OF MINUTES

Councilor Hargis moved to approve the minutes as submitted. Councilor Vazquez seconded the motion. The motion carried.

REPORTS:

Cherokee Nation Businesses - Shawn Slaton

Mr. Slaton reported on the financials for CNB. He gave a brief update on the success of the diversified businesses. He announced as a result of the Las Vegas shooting there would be drug dogs on site at Hard Rock for security measures. They have met and determined site plan and a building floor foot print for phase 1 of the Tahlequah casino at Cherokee Plaza. ODOT is requiring a wider turn in on HWY62 along with additional signals. He provided information on the Hard Rock renovation of the Sprung structure. He offered to answer questions from the report provided. Councilor Byrd inquired if the event center at the Cherokee Plaza would be able to host events like the Trail of Tears Drama. Councilor Walkingstick inquired about the revenue change

from the existing Tahlequah casino and the proposed new casino. Councilor Baker Shaw inquired about promoting the golf course at the Hard Rock. Chair Taylor commended them for the expenses coming in under budget. Councilor Crittenden inquired if there is a market for paper bingo. Councilor Lay inquired if we own or have an option on the property in Arkansas. He requested further clarification on the multi-purpose event center proposed for the Tahlequah casino. Councilor Hatfield inquired about a local market for a theatre group or act at the event centers that stay over a period of time.

Financial Report/Treasurer Report - Lacey Horn

Ms. Horn provided an update on the two boards she had been appointed to serve on in 2015. They are continuing to toward closing the books for the 2017 fiscal year. She offered to answer questions from the report provided.

Career Services/Employment - Diane Kelley

Ms. Kelley announced a diversified job fair in Vinita with 18 businesses is happening today. They are working with the new Dish call center in Tulsa. She provided some highlights on the recently held job fairs. They went to Jay last Friday to meet with a possible new wood chipping business. She touched on some of the other projects they are currently working on. She stated they are meeting with Health to determine training strategies for their upcoming employment needs. Councilor Hargis inquired about a vacant position in Stilwell.

Commerce - Anna Knight

Ms. Knight announced she didn't have any updated MAP figures to report at this time and offered to answer questions from the report provided. Chair Taylor requested clarification on the TERO complaints and EEOC Complaints referred to in the report, only 60% of our procurement opportunities to TERO and the numbers not being updated from CNE and CNB.

#### **CONSENT ITEMS:**

#### T.E.R.O. CERTIFICATIONS

Chair Taylor inquired about the 2 separate TERO certification lists. Ms. Kelley provided an explanation of the second list.

Councilor Byrd made a motion to table the joint venture. Councilor Anglen seconded the motion. Councilor Shambaugh requested clarification as to what is a "mentor Protégé" and the difference with a joint venture. Following discussion and concerns for the joint venture the motion to table this one certification carried with Councilor Lay opposed.

Councilor Hargis moved to approve all other items on both of the lists.

Councilor Vazquez seconded the motion. Councilor Lay voiced concern for the smaller Cherokee companies and the bonding issues. The motion to approve carried.

Mr. Harsha requested clarification on the basis for not approving the joint venture certification. He stated if the basis for not approving is solely on the notion that joint ventures are not appropriate or disfavored it would be inconsistent with what the law provides. He stated the application was certified by the TERO office and submitted

here merely for consent.

Councilor Lay made a motion to lay this certification back on the table for reconsideration. Councilor Vazquez seconded the motion. Following a voice vote there was confusion on the process.
