

Community Economic Impact




865 consumer loans totaling \$1,570,118 have been made through the Small Business Assistance Center in fiscal year 2024.


Small Business Lending Impact 2010 through 2024 by County

CHEROKEE NATION® Commerce Services Innovation Hub

The Innovation Hub is a business incubator and co-working space offering startups and existing businesses culturally tailored incubation services, workspace, mentoring, and training. The co-working space, located in the Cort Mall in downtown Tahlequah, offers patrons the option to reserve a hot-desk station, board room, classroom, pitch room, private office, and

coming soon, an outdoor workspace and podcast studio. All areas have access to free high-speed internet, general office supplies, a copy machine, and business development programming.

Each week, the Innovation Hub offers free business development programming and networking opportunities. The Innovation Hub Team, Mindy Madewell-Baker, Business Incubator Manager, and Lillian Thrasher, Business Coach, will facilitate the workshops and/or partner with area business leaders to ensure impactful and supportive small business and entrepreneurship content. All events are offered virtually and in-person. The Innovation Hub invites TERO certified businesses, area business owners in and around the 14-county reservation, and shares the invitation with area communities through partnership with Chambers of Commerce & Main Street Associations.


