WHEREAS, the appointment of members of the Board, replacing that portion of #36-89 previously addressing the appointment of said Board members, is provided for in Legislative Act 4-02;

WHEREAS, the term of office of Mike Crawley expired July, 2009 and has been selected to be renominated by the Principal Chief;

WHEREAS, Mike Crawley is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Mike Crawley is hereby confirmed as a Board Member of the Cherokee Nation Economic Development Trust Authority Board of Directors for the term of three (3) years from July 2009 until July 2012.
