CALL TO ORDER

Chair Lay called the meeting to order at 2:25 p.m.

Councilor Vazquez gave the invocation.

APPROVAL OF MINUTES

Councilor Baker moved to approve the January 13, 2014 regular session minutes. Councilor Walkingstick seconded the motion. The motion carried.

REPORTS:

1. Human Services Department - Marsha Lamb

Ms. Lamb reported they are gearing up for the Clothing Voucher Program. She announced they have received their final appropriation for LIHEAP. DHS has opened their crisis program. Councilor Byrd inquired about buying propane in bulk during the offseason when it is cheaper. Councilor Cowan Watts inquired about the Elders in Need Program and requested the qualifications be sent to the Council. She inquired about the status of the Tulsa/Rogers County Elder Advocate.

2. Community Services - Ron Qualls

Mr. Qualls reported a meeting was held a couple of weeks ago in regard to the implementation agreement with the Delaware where HUD decided to fund the Delaware's IHP for 2014. After discussion was held Chair Lay inquired since there

have been changes and the Council has already voted would it need to come back to committee for another vote. After clarification was given it was determined it didn't need to come back to committee as the changes are in the agreement not the resolution. Mr. Qualls provided an update on the Rehab program. He commented the youth funding program will be online as of next week.

3. Housing Services - Gary Cooper

Mr. Cooper reported the college housing application deadline has been extended to the end of the month due to the bad weather. He provided an update on the NAHASDA reauthorization. Councilor Cowan Watts requested confirmation there had been sixty-seven homes received by families through December. She requested the number of replacement homes over the last ten years.

4. Roads & Transportation - Michael Lynn

Mr. Lynn reported a bid for four bridges on the road between Jay and Kenwood in Delaware County is currently out to bid with a pre-bid meeting to be held on the 13th and a bid opening on March 4th. They will begin advertising around the first of March for Wickliffe Bridge in Mayes County. A meeting will be held this week on the intersection at Sequoyah High School. The goal is to have the SHS intersection project awarded for construction by May so construction starts during the summer while school is out. Councilor Garvin requested an update on the District 4 projects.
